Presentation:

- 1. Umesh Parajuli (UP), General Secretaty, welcomed the participants and highlighted the agenda anouncing the opening of the AGM, then requested Chairperson Shailendra Kaji Shrestha to present annual progress report and plan for forthcoming year
- Chairperson begun his presentation thanking to all participants for attending family gathering and AGM. He presented annual progress report (i.e. past one year of SONEUK's activities and achievements (file enclosed)). He also presented the plan for forthcomming year. Major highlights of the presentations were
 - Memorandum of Understaing (MoU)
 - EC meetings & Minutes of the 1st year (16 nos)
 - Major Activities (International Conference + Talk Programme + SMARIKA publication)
 - Training in GIS
 - Projects under study (H&S) in Nepal
 - Assets Creation (Prjector plus new website design)
 - Expansion of External Affair & liasion committee members
 - Members expansion and record in GIS data base
 - Interaction with Ex QGE
 - Constitution Amendment
 - Financial Update [Income (from membership, programme/events donations etc) expenditures and Bank Balances
 - Future Events Planned (Trainings, Talk programme, International Conference, MoU)
- 3. Chairperson finally thanked to all general members including executive team, advisors, committees team, regional coordinators for making last year very successful and wished for similar support in coming days. He also thanked for organisors of the event.



Floor Discussion:

- 4. All attendess were given opportunities to put question on any of the matter releted to chairmans presentation (AGM) or any general matters.
- 5. Former executive member Anjani Phuyal asked what benefits members can get from MoUs.
 - To this, Shailendra Shrestha informed one of benefits is to get platform (relevant technical institutions in Nepal) to share own knowlwdge/experience for which need to contact EC or relevant committee coordinator who can approach and help arranging a platform in technical institutions in Nepal. Thus our members can share their ideas and knowledge. This was not possible in the past due to lack of platform.
- 6. Bijay Bajracharya mentioned the NEACL have facility to conduct the webinar with that source SONEUK can run the talk programme in terms of technology and knowledge sharing.
- 7. Prof Keshav Dahal (KD) thanked EC for organising various programme/events and also suggested if family gathering date can be fixed quite earlier so that member can keep date in their dairy for participation.
 - Umesh Parajuli informed that July last weekend is the fixed date agreed in the earlier EC committee for family gathering but this time we organised one week later which is because of appropriate venue not decided soon. We wanted to fixed venue first to fit date. If date is fixed earlier and venue cannot find for the date then there could be problem. KD also advised if date is known, venue can be searched anywhere within UK convineantly. Shailendra Kaji Shrestha and Umesh Parajuli both welcomed the idea and agreed to come up with a date for next year in advance.
- 8. Dr Keshav Bhattarai (KB) told although his contribution to date is very low, but he suggested more of young members participation in the SONEUK is very important and our attention need towards this. He also advised to make facebook open to all publicly rather than keeping as close group.
 - Krishna Kishor Shrestha suggested youth members should be assigned the roles to conduct SONEUK events which can encourage more young to join SONEUK. Shailendra Shrestha added, SONEUK will coordinate for short term placement/experience course/training in Nepal (hospital, school etc) which could be useful to school level students who want some experience in Nepal.
- 9. Former Secretary Hari Krishna Neupane raised a question saying Mahabir Pun has requested SONEUK, as a charity organisation, to allow its bank account to collect cash



from UK donors to National Invention Centre in Nepal lead by Mahabir Pun, but wasn't agreed so far. Can't this be agreed?

- 10. Umesh Parajuli replied it was discussed in EC after EC received letter from Mahabir Pun, but did not agree the request sayng need more studies. The problem is that there can be an extra workload for executive committee. We all are working voluntarily, we are already strugling to manage our own accounnt internally, who can lookafter other organisation's account? EC also believed this will be risky task to handle other organisation's fund. There can be issue to provide annual financial report to HMRC. We need to study the wider impact to SONEUK including process and resource before making any decision. SONEUK respect Mr Pun's initiation in Nepal for good cause, but issue here is operational and practical difficulties and wider impact. Shailendra Shrestha also suggested that the topic can be discussed again in EC meeting later if required but it is not easy to decide. And, also there could be risk involvement to bothside, need to think and find longterm impact.
- 11. When there was no more questions, General Secretary then anounced the closing of the AGM thanking all for their participation.
